Our Lady of Lourdes Hospitality North American Volunteers Safe Environment Verification Form

The diocesan office of Safe Environment is responsible to ensure that all adults (age 18 and over) who minister to our children, youth and vulnerable adults have completed Safe Environment training and passed a criminal background check per the Diocese of Syracuse Child and Youth Protection Policy.

Any adult who currently lives in another diocese and would like to volunteer for North America Volunteers must complete the *Safe Environment Verification Form* (SEV Form) and submit to the Diocese of Syracuse Safe Environment Office *thirty* (*30*) *days* before departure. The form is attached and can also be found at <u>www.syrdio.org/SafeEnvironment</u>.

If you have completed the Safe Environment Training with Background Check:

- 1. Please *complete Part A* of the form on the reverse side. Present this to the coordinator of your home diocesan Safe Environment Program. *The director of Safe Environment will complete Part B*.
- 2. Mail, scan or fax the completed form to the address at the bottom of this page. *Email preferred*.

If you have NOT completed Safe Environment Training with Background Check:

- 1. Please contact your home diocesan Safe Environment Program about scheduling this training and to have a criminal background check conducted. Training information will be available on your diocesan website. Register for training and background check as soon as possible.
- 2. *You complete Part A* of form on back of this letter. Upon completion of the training, present the form on the reverse side, to the director of Safe Environment in your diocese, *to complete Part B*.
- 3. Mail, scan or fax the completed form to the address at the bottom of this page. *Email preferred*.

The Coordinator of the Office of Safe Environment of the Diocese of Syracuse will then confirm safe environment training attendance and a passed criminal background check by *signing Part C*. Both the volunteer and the North American Volunteers office will be informed once the volunteer is cleared to travel to Lourdes.

If a criminal background check cannot be processed through the home diocese, please contact the Office of Safe Environment in the diocese of Syracuse for assistance at 315.470.1421.

The Office of Safe Environment reserves the right to refuse clearance for any individual that does not complete the necessary paperwork and/or agree to a criminal background check.
